for several years now, the DMSB, the ADAC, the Nürburgring 1927 GmbH & Co. KG and the Racing Clubs have been putting special emphasis on environmental protection in all areas of their business.

As a result of this we expect as the organiser of the TRUCK-GRAND-PRIX 2022 from all participants and visitors that the rules for environmental protection are respected and adhered to. Adhering to all current legal requirements with regard to environmental protection is the basis for business. This particularly applies to rubbish disposal, protection of the ground and water as well as from emissions. Anyone infringing against these rules is damaging motor sports reputation in public. The current version of the rules of the Nürburgring 1927 GmbH & Co. KG in the paper "Notes on environmental protection for racing teams" is binding.

The ADAC Mittelrhein has also had its own environmental delegate for several years. He will answer all questions relating to that topic. Please be so kind as to support him in his work and grant him admission to all the sectors you are in charge of.

IMPORTANT INFORMATION !!!

Entry to the paddock can be gained from Tuesday 12th July 2022, 08.00 am. Advance entry must be approved by Nürburgring 1927 GmbH & Co. KG.

It is prohibited to hammer in earth nails. Exceptions must be approved in advance by Nürburgring 1927 GmbH & Co. KG.

NOTES FOR ENVIRONMENTAL PROTECTION FOR RACING TEAMS

WATER AND SOIL PROTECTION

- Oil and fuel have to be prevented from leaking and have to be stored
- Empty oil and fuel containers also need to be stored in an environmentally-friendly way and correctly so that there can be no danger to third parties. Storage behind the pits towards the paddock is forbidden.
- In the event of harmful liquids leaking they are to be soaked up with binding agents and cloths

WASTE DISPOSAL

- Sort your waste into the appropriate trashcans.
- Especially hazardous waste should be sorted into the appropriate trashcans:
 1. Put used oil into the red used oil containers
 2. Solid oil waste such as oil filters and cloths are to be put in the red trashcans

NOISE AVOIDANCE

- Avoid unnecessary noise of vehicles in the interest of the residents.

SAVING WATER AND ELECTRICITY

- Keep car washing and any other water consumption as well as the energy consumption to a minimum as far as possible.

NOTES FOR ENVIRONMENTAL PROTECTION FOR HOSPITALITY AND CATERING AT THE NÜRBURGRING

1. General Notes

- Keep to deadlines for building-up and taking down the tents as well as any other facilities.
- It is strictly prohibited to put earth nails into the asphalt or concrete surfaces.
- No handing out advertising (pamphlets, magazines or promotion articles) in the outer area or carpark
- Clean the rented area and throw away all waste after taking-down.
- Forward these notices for environmental protection to the companies working as sub-contractors (caterers).

2. Waste Disposal

- Avoid waste by only using recyclable beakers and dishes, that means, no serving in non-returnable drink and food wrapping.
- Use multi-applicable floor covering instead of one-way floor covering (more cost saving in the long-term).
- Keep to the waste separation stipulated by law.
- Instruct catering and kitchen staff how to separate rubbish.
- Order waste containers at the Nürburgring 1927 GmbH & Co. KG at the latest 4 days before the event on +49 (0)2691 302 9399.
- The grey and yellow waste containers for spectators are not to be used by the hospitality operator. Do not remove these containers from the foreseen place.

3. Sewage disposal

- Kitchen and dishwasher sewage is to be connected to the sewage system or mobile sewage tanks. **Sewage drains are marked green.**
Red-marked drains are only for clean rainwater. Sewage tanks can be ordered at Sani GmbH, Phone +49 (0) 2691 / 939 887 30.

4. Water and Energy consumption

- Be saving with water and energy when washing the car, operating the kitchen, lighting and heating.
- For kitchens only drinking water pipes can be used which have been checked in accordance with „KTW“ or „DVGW W 270“.
- During the event vehicles may not be washed within the paddock.

NOTES FOR WASTE SEPARATION FOR HOSPITALITY AND CATERING **(PLEASE HANG UP IN THE KITCHEN AREA AND INFORM THE KITCHEN STAFF).**

The following waste will be collected and disposed of separately:

1. Reusable material (with a green Point):

- Packaging
- Tins
- Plastic films
- Plastic cups and plastic bottles
- Drink packaging etc.

2. Glass

3. Paper, Cardboard

4. Left-Overs (without packing parts)

No other material such as remaining waste or packaging

5. Remaining Waste

Dishes of chips, rubbish, napkins, dirty paper etc. No reusable materials! No glass!

6. Bulky Refuse:

Carpet remains and other bulky waste.

We ask you to follow these notes. For unsorted waste you will have to pay the costs for sorting.
